Holly Coon, Audit Program Director, referred the meeting attendees to her written report. During the first three quarters of FY 2024, the income tax program proposed net assessments of \$239,554,230 for completed and partially completed income tax audits. The income tax program staff also proposed NOL reductions of \$2,217,973. The sales tax program proposed net assessments of \$3,231,322. Holly also highlighted staffing changes during the fiscal year. Jackie Dalenberg, sales tax auditor, retired in July. Angie Kaur Grewal was hired in February to replace Jackie. Income tax auditors Ben Morris and Bill LoCascio resigned in April to join the IRS. The audit program is actively in the process of hiring two new income tax auditors.
