III. APPROVAL OF PUBLIC SESSION MINUTES

The minutes of the public session of the Audit Committee meeting on May 1, 2024, in Kansas City, MO, were approved unanimously with a motion by Michael Williams, Alaska.

IV. AUDIT DIRECTOR'S REPORT

Holly Coon, Audit Program Director, referred the meeting attendees to her written report. During the 2024 fiscal year, the income tax program completed 4 audits and parts of 8 audits with proposed net assessments of over \$297 million for completed and partially completed income tax audits. The income tax program staff also proposed NOL and tax credit reductions of just over \$2 Million. The sales tax program completed 4 audits and parts of 5 audits with proposed net assessments of \$8.5 million. Holly also highlighted staffing changes during the fiscal year. Jackie Dalenberg, sales tax auditor, retired in July. Angie Kaur Grewal was hired in February to replace Jackie. Angie resigned in June. Income tax auditors Ben Morris and Bill LoCascio resigned in April to join the IRS. Kim Stewart, sales tax auditor, resigned in July. The audit program is actively in the process of hiring two new income tax auditors and will also hire one sales tax auditor in the fall. About training, Holly noted that there have been requests for corporate income tax training and there are plans to record corporate income tax modules with an audit focus. Unfortunately, the status of current audits have not allowed staff much time to focus on this training.

V. REVIEW AUDIT COMMITTEE CHARTER

No changes were suggested for the Audit Committee Charter. Aaron Yost, Idaho, submitted a motion to maintain the charter in its current version. The motion was unanimously approved with a voice vote.

VI. SALES TAX COMPLIANCE ASSURANCE REVIEW PROGRAM

Nikki Dobay presented an outline proposal for a Sales Tax Compliance Assurance Review (ST-CAR) program. Nikki had previously pitched some loosely formed ideas of this type of program at the November audit committee meeting in Montclair, New Jersey. This meeting's proposal was more detailed, and Nikki hoped that providing a more detailed proposal would allow the committee to more clearly identify the program's viability. After the proposal was discussed, members of the committee determined that the best course of action was to allow the committee members more time to digest and

consider the program. An agenda item to discuss this proposal will be added on both the open and closed agenda in the fall committee meeting in Santa Fe, New Mexico in November.
