Bryan Kelly, Chair (WA), brought the meeting to order at 8:30 am MDT, introductions of attendees were made, and public comment was invited.

#### Public Comment

No public comment was offered.

#### Minutes

Aaron Yost (ID) moved for approval of the minutes of the May 1, 2024 open session portion of the Nexus Committee meeting, and the minutes were approved by unanimous voice vote.

# Nexus Director's Report and Update on Recent Nexus Law Developments since May 1, 2024

Richard Cram, Director of the National Nexus Program, reviewed for the Committee his Update on Recent Nexus Law Developments since May 1, 2024 and the FY 2024 Nexus Program Director's Report. Back tax collections from agreements closed between July 1, 2023 and June 30, 2024 were \$28,743,260 with 494 executed agreements. This surpassed the previous record established in FY 2022 of \$28,337,506 and 493 executed agreements. Richard stated that a Nexus School was held in Charleston, WV on May 16-17, 2024, hosted by West Virginia Department of Revenue. He encouraged other states interested in hosting one to contact MTC training staff.

### Gary Bingel presentation

Gary Bingel, attorney with EisnerAmper Consulting, Iselin, NJ, gave a virtual presentation concerning his experience in representing clients seeking to participate in state voluntary disclosure programs. He had several observations and suggestions for state voluntary disclosure staff to consider. He stated that taxpayers liked to have the option of either filing spreadsheets or prior returns for sales tax, rather than being required to file one way or the other. He indicated that when a state's voluntary disclosure office is understaffed and cannot timely process voluntary disclosure applications, this creates a hardship for taxpayers, particularly those involved in mergers and other escrow situations under time constraints. He pointed out that when states can deviate from their standard lookback periods and impose longer periods under certain circumstances, this creates uncertainty for the taxpayer and a deterrence from participating. He noted that some states will not allow electronic filing for prior year returns, and this creates a burden on taxpayers that must then file those returns manually. He recommended that states should encourage taxpayers with collected but unremitted taxes to come forward by offering them penalty relief. He suggested that the voluntary disclosure agreement should be executed prior to the back tax year returns being filed, instead of holding the agreement in abeyance until the returns are filed. He also recommended that taxpayers be allowed at least 90 days to file those returns after execution of the agreement. He thought that voluntary disclosure should remain an option for taxpayers during amnesty periods. Also, new tax types established in a state need to be included in the voluntary disclosure process.

# Approval of Nexus Committee Charter

Chair Bryan Kelly brought up the Nexus Committee Charter, which needs to be considered annually for possible revisions. No revisions were requested. On motion of Frank Hales, the Committee approved the Nexus Committee Charter by unanimous voice vote.

# New Business

Chair Bryan Kelly asked if there was any new business, and none was proposed. The Chair then reminded everyone and encouraged attendance at the following upcoming meetings:
